Dental Van Continues to Provides Sisters Community with much needed dental care. By Jan Failing

Hank and I want to extend our sincere gratitude from our dental van volunteer team (including Julie Mansfield, Career Opportunity Fund recipient) and the patients we serve in Sisters, for your generous donation of \$1500, helping us bring the Medical Teams International dental van to our community for 5 (@ \$300) clinics in 2015. Without your support we would not be able to provide needed restorative and preventive care to those in our community who, due to financial difficulties, are without access to these services.

Over the past 5 years we have been working with our patients through comprehensive treatment, education, and compassionate commitment, to break the cycle of needing to seek preventable emergency treatment. We are seeing a significant change in those members of our community we serve by the reduction in the need to schedule "Urgent Care" clinics in Sisters and an increase in those returning for routine preventive care after their restorative treatment is completed. Due to the type of services we offer, our schedule is constantly full and our waiting list is forever growing...no complaints however! This reduces the number of cancellations, forgotten appointments and patients not showing for their scheduled time.

We ask our patients to make a small donation of \$10.00 per appointment, if they are able (no one is ever turned away because they cannot pay). We let them know their donation goes toward bringing dental clinics to Sisters. "Free" services often go unappreciated, but if they feel they are helping and contributing to a worthwhile cause, they become engaged and committed...an investment in their own health!

At the meeting we shared some statistics, gathered by Debbie Stumbaugh (MTI dental van coordinator). We feel these figures give a dramatic picture of what can be accomplished by a team of volunteers, good resources, and supportive donors.

In 2014 we sponsored 12 dental clinics for our Sisters

Country citizens in need. We served 108 adults dental services valuing \$42,619.00. Our volunteers (4 for each clinic) worked 346 hours performing such services as comprehensive and routine exams, X-rays, preventive cleanings and periodontal treatment, restorative services including amalgam and composites fillings...a well as, occasional emergency, temporary palliative treatment and referrals when treatment is needed beyond the scope of our clinics.

Without your financial support, we would be unable to bring these services to our community members in need!

Thank you again for your generous contribution to our efforts, both to our Sisters Kiwanis Club and to those members who made a personal donation to our cause!




